You can obtain information about these services several different ways. Someone at each of the numbers below should be able to direct you to the appropriate referral. If ever you are experiencing a crisis, contact Crisis Services at 814-456-2014 or toll free at 1-800-300-9558.

**If you have a Medical Assistance Card**, it is likely you are eligible for behavioral health services paid by the Erie County HealthChoices services provider, Community Care Behavioral Health (also referred to as Community Care within this document), located at 1314 Griswold Plaza Erie, Pa 16501. **Community Care's Member Services line is available 24 hours a day, 7 days a week at the toll-free number 1-855-224-1777, 1-833-545-9191 (TTY) or 1-866-229-3187 (En Espanol). <b>Clinically Managed Low-Intensity Residential Services (Halfway House)- LOC 3.1</b>	Programs that offer a supportive living environment with 24-hour staff and integration with clinical services to include at least 5 hours per week of onsite SUD treatment. Treatment is characterized by services such as individual, group, and family therapy; medication management; and psychoeducation. These services facilitate the application of recovery skills, relapse prevention and emotional coping strategies. They promote personal responsibility and re-integration of the individual into the network systems of work, education, and family life. <b>Emergency Shelter Services</b>	Emergency shelter services for <b>adults</b> with serious mental illness or substance abuse problems (and their families) who are also homeless. <b>Homeless Prevention Services</b>	Rental subsidies for eligible individuals to avoid loss of permanent housing.	Erie County Coordinated Entry – (814)SHELTER (814)743-5837

<b>Permanent Supportive Housing Shelter Plus Care</b>	Support services and rental subsidies for eligible <b>adults</b> with serious mental illness or substance abuse problems who are also homeless. INTELLECTUAL DISABILITY SERVICES	DESCRIPTION	ERIE COUNTY PROVIDERS
<b>Agency with Choice</b>	A service delivery option in which individuals with an Intellectual Disability/Autism and/or their family members are able to self-direct their services. This model of services encourages individuals and their advocates to be directly involved in the planning, scheduling, hiring, and management of support workers. A joint relationship is formed between an individual and/or family member with a liaison who provides administrative help to assist in managing services. The goal of this support is to enable families to remain together in their own homes. The program offers many services that individuals and families can choose from including: In Home and Community Support, Companion, Respite, Camps, and Home and Vehicle Adaptations.	<ul style="list-style-type: none"> <li>• <a href="#">Barber National Institute</a></li> </ul>
<b>Behavioral Supports</b>	Services that can be provided in instances where an individual is exhibiting behavior that is problematic for them and those they live with, and where other natural or support staff do not have an effective strategy to support the person. Support includes the services of a Behavior Specialist professional to conduct an assessment and develop a Behavior Support Plan. Competitive integrative employment refers to full or part time work at minimum wage or higher, with wages and benefits similar to workers without disabilities performing the same work. Services are intended to flexibly wrap around or support community life secondary to employment as a primary goal. This service involves participation in activities in integrated community settings that involve persons without disabilities who are not paid or unpaid caregivers. The service is expected to result in the person developing and sustaining valued social roles and relationships, building resources and experiences in the community, increasing independence, increasing potential for employment, and experiencing meaningful community participation and inclusion.
